#### CALIFORNIA UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT

The County of Sacramento adopted the California Uniform Public Construction Cost Accounting Act (CUPCCAA). This allows the County of Sacramento to informally bid construction projects ranging from \$60,000 to \$200,000, and for negotiated contracts below \$60,000.
